Standard Benefits

| Daily Hospital Confinement Benefit | Payable for a maximum of 30 days per confinement at \$300, \$500, or \$750 per day. |
| Surgical Benefit | Benefits payments are based on benefit schedule up to a maximum of \$1,000 or \$1,500 per procedure. |
| Anesthesia Benefit | Benefits are payable at 20% of the surgery benefit |
| Doctors Office Visits | Covers up to 6 visits per calendar year at \$25, \$50, \$75, or \$100 per visit. |
| Outpatient X-Ray & Lab | Covers up to 3 tests per calendar year at \$25, \$50, \$75, or \$100 per test. |
| Outpatient Prescription Drug Benefit | Covers up to 12 prescriptions per calendar year at \$10 or \$20 per prescription. |
| Off-the-Job Accidental Injury Benefit | Covers up to \$300 or \$500 per covered accident, maximum 5 occurrences per calendar year. |
| Accident Only Ambulance Benefit | \$150 per trip, maximum of 3 occurrences per calendar year |

| Additional In-Hospital and Surgical Benefit | \$1,000 per confinement, maximum of 2 confinements per calendar year |
| Daily Intensive Care In-Hospital Benefit | \$600, \$1,000, or \$1,500 per day. Maximum of 30 days per confinement. |
| Wellness Benefit | \$25, \$50, \$75, or \$100 per calendar year 6 or 12 month waiting period |
| Critical Illness Benefit | Pays \$2,500 when an insured is diagnosed with a critical illness in addition to other benefits received under the Select plan. |
| Subsequent Critical Illness Benefit | Pays \$2,500 when an insured is a diagnosed with a subsequent and separate critical illness within 60 days of the original illness. This is in addition to other benefits received under the Select plan. |

Exclusions

The Basic Care plan does not cover pre-existing conditions* during the first 12 months of coverage. Dental and routine eye care is not covered. Other exclusions apply. A complete listing of plan exclusions is included in the Policy and Certificate.

**Pre-Existing Condition: A condition for which medical treatment or advice was rendered or recommended by a licensed physician within 12 months prior to the effective date of coverage; or the existence of symptoms, which would cause an ordinarily prudent person to seek medical diagnosis, care, or treatment during the 12 months prior to the effective date of coverage.*

NOTE: A minimum of 25 employees must enroll for coverage.
